Wylie sales tax revenue increases

The city of Wylie receives a sales tax reimbursement check from the Texas State Comptroller this month for \$653,853, a 4.32 percent increase from a year ago.

Reimbursements to Texas cities were distributed by the

comptroller this month for taxes collected on retail sales made in November.

In January 2015, the check to Wylie was \$626,739.

Statewide, the comptroller distributed sales tax proceeds to cities totaling \$402 million this

month, up .04 percent from the January 2015 total of \$401 million.

Cities in Collin County are reimbursed a total of \$19.7 million this month, down 2.58 percent from the \$20.25 million received from the comptroller a year ago.
