New Permit Renewal Update

Alarm Ordinance: 38-22 requires the name, business/resident telephone number and the phone numbers of three additional key holders who are authorized and have agreed to receive notification at any time from responding police/fire personnel to come to the alarm site with 30 minutes after receiving such notification. Four key holders maximum maybe listed to attend to the site with a maximum of eight telephone numbers.
