



Wylie Teen Court Attorney Application

The primary goal of Wylie Teen Court is to attempt to teach accountability and responsibility in juvenile offenders' ages 10 - 17 years of age. The juveniles who appear before their peers in Teen Court are referred by the juvenile case manager to the prosecutor and to the judge. Each case considered for Teen Court is on a case by case basis. The most important factor will be that the juvenile admits his/her guilt of the charges.

The juvenile offender will appear in Teen Court with his/her parents. A teen attorney will explain the facts of the case to the teen jury along with a teen attorney representing the state. The teen jurors will then have a chance to listen to the juvenile defendant answer questions about the incident. After deliberating, the teen jury will come up with the terms of the juvenile defendant's case to keep the offense off of their record. The sentence handed down by the jury will always consist of community service and can additionally include participation in educational programs or other mandatory programs.

Teen Court meets the 2nd Wednesday of every month from 5:30 to 8:00pm. To be considered you must be at least 15 years old and available during those times. You must be able to commit for at least one school year. If you are selected from the application process, you will be required to attend a mandatory Teen Court Attorney Training Session.
