**Sec. 102-2. Gatherings on public streets.**

- (a) Parties, gatherings, etc., which involve the blocking or closing off of public streets and/or thoroughfares are prohibited in the city, except under the circumstances and provisions listed as follows:
  - (1) Contact the chief of police of the city, or his designated representative, and advise of the date and time of the desired party.
  - (2) The chief of police or his designated representative will advise the organizers of the following:
    - a. Must have a letter signed by residents affected by such party, giving their consent and approval of such party, to be placed on file with the police department.
    - b. Contact the director of public works, or designated representative and make arrangements to pick up city barricades with which to block off street where party is to be held.
    - c. Streets must be left open to the extent that emergency vehicles can gain entrance without delay of any kind.
    - d. Parties must be conducted in such a manner as not to be in violation of any other ordinance of the city, particularly those regarding public nuisance with excessive noise from loudspeakers, etc., public intoxication, and/or disturbing the peace.
- (b) The chief of police, or his designated representative, will be responsible for posting the fact of the block party in question for the information of the police officers on duty during the hours of the celebration and for the information of the dispatcher on duty, in case of inquiries by the citizens.
